SHORT BIOGRAPHIES OF THE PARTICIPANTS

Harris Dellas received his Ph.D from the University of Rochester in 1985. He is Professor of Economics and Director of the Institute of Political Economy at the University of Bern, Switzerland. He has previously been on the faculty of the Catholic University of Louvain, the University of Bonn, the University of Maryland and Vanderbilt University. He has also held a number of visiting positions at various European and US universities as well as at several central banks and the IMF. His current research focuses on international monetary arrangements, financial markets and monetary policy.

Ege Cansen received his BS degree in Business Administration from the Middle East Technical University and his MBA from the Wharton School of the University of Pennsylvania. He served as Assistant General Manager of Arçelik, Industrial Affairs Coordinator of Koç Holding, Manager of Soyer Hafriyat and Managing Director of Anadolu Endüstri Holding. Teaching Business Economics at Marmara University between 1987 and 2000, Mr. Cansen has worked as an Economics Columnist at *Hürriyet* daily newspaper since 1983. Mr. Cansen is also a shareholder of Cansen & Cansen Management Consultancy.

Manfred J. M. Neumann is Research Professor at the Research Centre of the Deutsche Bundesbank. He has been professor of economics at Bonn University since 1981 and director of the Bonn University Institute for International Economics. Previously he taught at the Free University of Berlin. He is a member of the Academic Advisory Council of Germany's Federal Ministry of Economics and Technology (chairman 1996-2000) and a member of the Academy of the Sciences and the Arts of Northrhine-Westfalia (president 2006-09). The main focus of his research interests is on monetary and international economics.

Serhat Gürleyen received his BA degree from Boğaziçi University, where he also started his professional career as a research assistant. After working in research, international sales, and fund management departments of Turkish financial sector, he joined İş Yatırım in 2002. He is currently Director of Research at İş Yatırım, and is responsible for the development of investment strategies for the customers. Mr. Gürleyen has been a columnist for daily Dünya since 2006. He holds the CFA (Chartered Financial Analyst) designation.
